

**DISCIPLINARY CODE  
OF THE FACULTY OF SCIENCE,  
JAN EVANGELISTA PURKYNĚ UNIVERSITY IN ÚSTÍ NAD LABEM  
OF 28 FEBRUARY 2018**

**Article 1**

**Opening Provisions**

1. The disciplinary procedure for students in the study programmes of the Faculty of Science, Jan Evangelista Purkyně University in Ústí nad Labem (hereinafter the “faculty”) is regulated under Section 31 and Section 64 to Section 69 of Act No. 111/1998 Coll., on higher education institutions and on the amendment and supplementation of other acts, (Higher Education Institutions Act), as amended, (hereinafter the “Act”), also the UJEP Disciplinary Code and within its framework also by this Code.
2. The Disciplinary Committee of the Faculty of Science, Jan Evangelista Purkyně in Ústí nad Labem (hereinafter the “disciplinary committee”) has six members and two alternate members. The functional term of the members and alternate members of the disciplinary committee is two years and starts running on the date on which they are appointed to office by the Dean.
3. The chairperson of the disciplinary committee is elected and recalled by a majority of more than half the members of the disciplinary committee.

**Article 2**

**Meetings of the Disciplinary Committee**

1. Any member of the faculty’s academic community can appeal to the Dean for disciplinary action.
2. The discussion of a student’s violation of obligations according to Section 64 of the Act by the disciplinary committee is open to the members of the faculty’s academic community with the exception of meetings and voting, which are not public.
3. The proceedings of the disciplinary committee are entered in the minutes, which contain a description of the act, or suggested evidence, which is the basis of the Dean’s proposal for the start of the disciplinary proceedings, also the discussed proposals for the resolution of the disciplinary committee and the result of the undertaken vote. The minutes shall be signed by all the disciplinary committee members who are present and participate in the vote. The minutes are issued in two originals, whereas one is submitted to the Dean and the other is archived in the faculty’s study department.
4. Discussion of the student’s violation of obligations according to Section 64 of the Act may be interrupted by the disciplinary committee for the purpose of submission of additional evidence.

### **Article 3**

#### **Final Provisions**

1. The Disciplinary Code of the Faculty of Science, Jan Evangelista Purkyně University in Ústí nad Labem approved by the UJEP Academic Senate on 27 September 2006, as amended, is hereby repealed.
2. In accordance with Section 27(1)(b) of the Act, these draft Rules were approved by the Faculty's Academic Senate on 14 February 2018.
3. These rules were approved by the Academic Senate of Jan Evangelista Purkyně University in Ústí nad Labem on 28 February 2018 according to Section 9(1)(b)(2) of the Act.
4. This Code is valid and comes into force on the date of approval by the UJEP Academic Senate of Jan Evangelista Purkyně University in Ústí nad Labem.
